

TICOLAND FISH COLLECTING By Eugene T. Aldridge Jr.

Part two-

On Wednesday went back up the Pan American Highway looking again at the streams we had looked at on the way down. A more careful study of each was made this time. There turned out to be no fish to be had, maybe to close to civilization. We went off the road a ways and came to the Rio de Oro. It was nice to cool off in and a native was catching his dinner but it was not good for our purposes. big and fast. We were starting to think that the day was to be a real bust, but then George suggusted taking a side road for a few kilometers to see if things would look better. Shortly, we came to a stream that looked good. We parked almost in the water, so I was really close to the action. It turned out to be the best place we could have ever found and made up for all the poor luck we had earlier in the day. filled all the buckets and boxes we were carrying. A bridge was right beside us for the people and trucks to use. Every one stopped to ask what we were doing or to say "HI". I was caught trying to carry on conversations with passerbys that knew VERY little English and I knew even littler Spanish. But we did quite well. I was told on the troops return that they had watched while someone poisoned part of the stream bed to catch crayfish. The regular fish were able to move out fast enough, but the crayfish could not move that fast. The sun was going down so started back to Golfito with a quick stop at the first stream to check the fish trap. Again there was nothing worth while, so we continued on to Golfito.

Again we sorted out the fish by types and checked the ones we caught the day before. We now had all the fish that we could possibility bring back with us. We showered and returned to the El Caldero for dinner. I do not remember what I had as I was very tired. Again we visited for awhile before going back to our cabins to pack so we could start back on Thursday morning. One nice thing is that the water was very good. Water was changed by the bucket full right from the spigit. The fish were in styro boxes on the porch, it did not get cold enough at night to worry. About 10:30 I went to bed and slept very well.

The next morning we went back to the El Caldero for breakfast. The Land Cruiser was checked and fueled before starting back up the mountains. It turned out that 4 quarts of Oil were needed and it took about 45 minutes to get the oil and diesel fuel in. The fuel sold by the liter at 190 colones, or about \$4.00 a gallon. Golfito is an old "company" town from the banana days. When Costa Rica put an export tax on bananas, the Great American Fruit Company moved out leaving the typical company town with its associated problems. The REAL URGE to work is gone. We now started back toward San Jose with a planned overnight stop at San Isidro. The weather was wonderful and the trip was uneventful. On the way we passed through thousands of acres of pineapples. We stopped at a roadside stand to pick up one to eat later. We stopped at a nice motel in San Isidro in time for lunch and for me and Paul to rest while George and Jake got in some fish collecting in local streams. They went back down the about 19 kilometers. In a few hours they came that we a few good fish **so we decided we** would make a quick stop in the m_0 -raing before leavin,

for San Jose. Dinner was good but not outstanding.

The next morning we started early so we go back to the place George and Jake found fish, however, to our surprise the Land Cruiser would not start. So Paul made a call to Hertz in San Jose to find out what to do. It took a while a mechanic to get there, so after a lot of talk we learned that we might need a new battery. However, the mechanic wanted the it up at his shop. So not being able to find a chain or cable to tow it up there it was pushed until it started. When Paul and George returned in about an hour Jake and I learned the cost including the service call was only about \$8.50 American. The mechanic had only cleaned off the battery terminals and put new brass ends on the battery cables. The end result the battery worked very well. He told us to tell Hertz that the battery was not any good and would not last much longer and should be replaced. We found dates on the battery indicating it was made in 1967, so it was nearly 20 years old. The Ticoland mechanics are able to do wonders with a standard transmission car making them run with chewing gum and baling wire. Many of the trucks I saw were 30 to 40 years old. Maybe this is where the old junk heaps I turn in go. After this eposide was complete we just decided to go straight to San Jose without our little side trip. We again drove up over 10,000 feet, the scenes were just as beautiful a second time as they were the first time. While we were driving we discussed what we were going to do on Saturaday. Go on one of the tour trips to the volcano north of San Jose or stay just in the city. Paul advised me to stay as there were long walks at the volcanos, so all decided to stay in the city. We got to the University in San Jose without further incident. Bill Bussing was ready for with plenty of empty tanks ready for fish. The fish were put in the tanks and some more sorting was done in the better light and more space.

Once this was done we returned to the Grand Hotel to check in then go out to dinner. The previous week Paul had found an Italian Restaurant within walking distance. So off we went. Again we had our beer and some local cheeses to start with. The owner was Italian recommended a special combination and to top it off he said we could have it free if we did not like it, so we had the special. It was super so he was not taken up on his offer of a free dinner. It was not really very far to walk, but the sidewalks were terrible with holes, and brick and coblestone for covering. I was lucky not to have fallen. Paul had found out that there was to be a craft fair right outside the hotel on Saturaday so we would be in heaven getting things to bring home.

Saturday we were all lazy but eager to get some things to take home with us. About 8:00 people started to set out in front of the Hotel. I went once or twice and looked but it was a mad house and I was getting pushed around to much so I stayed away. Later on in the day, we went to a fancy leather goods place, Marroquinerias Del Rio. They came and got us and brought us back. We were able to get some real nice leather goods. I came away with several ladies pocket books, belts and wallets, enough to cover birthdays and Christmas for the rest of the year. I got some other things for myself at shops around the hotel and other than this took things easy. I just sat in front of the hotel for several hours just watching people. Saturday evening we took the Bussing's to dinner at the same Italian Restaurant we were at the night before. I had the same thing and it was still very good. The

dinner was slow in coming but an enjoyable time was had by all just talking. This was just a little something we could do for Billfor all he had done in getting the inecessary permits for us to do what we did. After walking back to the hotel we said our goodby's to Mrs. Bussing and told Bill we would be at the University in 30 minutes. We went to our rooms to change back into our old clothes for one last time then left for the University and a fish packing excerise. packing 7 boxes of fish. The size of the boxes I had taken turned out to be very good because loaded fish bags could stand up in the allowing 10 to 12 bags to go in each box. After we were done we said our final goodby's to Bill and returned to the hotel. We got to bed about midnight with a call to get up a 6:00 so we could be at the airport for an 8:00 flight. The fish had been left in the Land Cruiser so we did Then to bed for a short rest before the next not have to move them. steps in our journay.

We arrived at the airport in time only to find out that Eastern had gotten VERY tight on the size of your bagagge. So to get the fish home we had to pay an extra \$125.00 American. This, to me, was not to bad since there were 7 boxes of fish and 4 bags with our personal I put it on one of my plastic cards and we moved on. getting our seat assignments getting our pasports stamped and turning in our Tourist Cards and were waiting for the plane we were told the plane lights had been left on all night and the battery was dead. back down stairs we went leaving our passports on the way. Eastern gave us a breakfast ticket for the restaurant. It was now about 11:00, but the waiter would only let us have breakfast not lunch which is what About 12:30 a new battery was brought in on a all wanted now. flight from South America, so about 1:00 we left. Because of all the problems we were not going to make our flight from Miami to Newark so were rebooked on flights that would take me to National, George to Providence and Paul to Newark. But since the were booked through to Newark we let them go. My flight was to leave Miami at 5:10 and we did not get in until 4:45. I had asked for a wheelchair as Paul told me there would be a lot of walking. I got one, but no way could anyone have gotten through Immigration, Customs, to the other end of Miami Airport and on a plane in the time available. The young lady pushing my wheelchair knew all the right steps to take. Immigration had a special line for U.S. citzens and you were run right through, the Agent looked at my passport and me smiled then asked was it good to be home-I said Yes and he passed me on. Customs was a mad house with all the lugagge from many flights coming in. We saw Paul and company waiting for theirs but they mine was coming around, so I waited for it, in a minute it was there. Now for Customs. My wheelchair pusher moved me up in front of the line. The agent asked a few questions about what ${f I}$ had brought home, ${f I}$ answered and she passed me through. By now ${f I}$ had missed the 5:10 plane. So I had to be rebooked onto a later flight that was leaving at 5:45. I finally got a standby ticket and seat. I was the next to last on the plane and every seat filled.

The flight to Washington National was uneventful taking a little over two hours. I got home about $9{:}00$ without my lugage. I had been told it might not make the flight so I was not surprised. The Trip was now over. It is some thing that I will never forget. It is something that I would love to do again. The people in Costa Rica were wonderful, you could not have asked for better hosts.

TRICHOGASTER TRICHOPTERUS

Trichogaster Trichopterus is more commonly known as the blue gourami, three spot gourami, or its variations the Cosby (opaline) gourami and the gold gourami. The version I bred was the gold gourami. This is a rather peaceful anabantid form Sumatra which does well in the community tank. They are easily maintained, water conditions are not critical, and they will eat most any prepared foods with no trouble.

I bought a nice pair about four inches in length from a local pet shop. The female was slightly smaller than the male and already well rounded when I purchased them. The fish were set up in an established ten gallon tank with a gravel bottom and a sponge filter on the back side of the tank. There was some java fern and spawning grass in the tank. The water level was about four ".

Upon placing the fish in the tank, I turned off the filter and gradually raised the temperature from 74 to 82 degrees. Some black water extract was added to help soften my very hard water (dhl2). The fish were fed frozen blood worms, frozen brine shrimp and a variety of flake foods.

Spawning came about a week later. The male built a rather large bubble nest anchored in the spawning grass. I removed the female although she did not seem threatened by the male. I have had bad experience with other anabantids when I left the female after spawning.

After about 36 hours the bubble nest disappeared and the golden colored eggs were left floating in the spawning grass. Less than 24 hours later the fry hatched and were free swimming about two days later. At that time I removed the male.

There was no way to estimate the number of fry once they were free swimming. Like another fish of the same species I've spawned, Trichogaster Leeri (pearl gourami) there was a virtual cloud of fry filling the tank, I would guess at least 500. After three weeks I moved about one third of the fry to a second tank to give them room to grow.

The fry were fed on infusoria, strained egg yolk and liquifry to begin. After three weeks baby brine shrimp, micro worms, and micro eels were added as well as tetramin egglayer flake food. Water changes were frequent, 5-10% every other day. After about 45 days I suffered a large scale loss of fry. I read that feeding these fish could be difficult at the early stages which will cause some loss.

Growth has not been as rapid as with other anabantids and after 60 days most of the approximately 100 surviving fry are about 5mm in length. The gold gourami was very easy to breed. With more care, perhaps more frequent feedings than the twice a day I was able to provide, more of the fry would have survived.

The first item discussed was the upcoming PVAS picnic on 17 August at Pohick Bay Park. Bob Roser volunteered to obtain all food and supplies for this event. It was decided to postpone this suggestion until the Board has a clearer picture of the club's financial position later this year.

It was discussed and decided to augment the month raffle prizes with items such as drum bowls, heaters, and small tanks, beginning this fall.

Plans for the PVAS fall workshop and auction were discussed. Bob Pallansch and Kenny Warren will negotiate rates and reserve the room. It is hoped that a series of experts on various hobby topics will agree to speak at the Saturday workshop, followed that night by the fall banquet, followed on Sunday by the fall auction. Further details will be available at the July meeting and in the Delta Tale.

The meeting adjourned at 9:40 PM.
